## **THE ISRAEL ASSOCIATION OF ACTUARIES**

The Israel Association of Actuaries (ILAA) was founded in 1946 by a group of nine actuaries, who had received their mathematical training in Europe. The number of members grew gradually to about 50 in the 1970's. Until 1989 there was no regular training programme for actuaries. One-off courses in actuarial science were run by the Hebrew University in the 1960s and Tel Aviv University in the 1970s, which provided sufficient qualified actuaries at that time, together with a number of immigrants trained by the Institute of Actuaries in the UK or the Society of Actuaries in the USA.

In 1989, a permanent course in actuarial science was established at Haifa University with the assistance of City University in the UK, and continues to this day. The Association enables members to take the examinations necessary to become Fellows. In recent years this has been done in cooperation with the Institute and Faculty of Actuaries (IFoA) in the UK. Under a special agreement, the examinations of the IFoA are held in Israel and marked by local examiners. The Magid Institute, associated with the Hebrew University of Jerusalem, organizes courses to train students for the examinations of the IFoA.

In 1995, the ILAA was one of the founder members of the International Association of Actuaries (IAA), which was set up to unite the professional activities of actuaries around the world. Edward Levay, a veteran member of the ILAA, served as a President of the IAA, and other members continue to play an active role on committees and boards of the IAA. The ILAA has hosted a number of international actuarial gatherings, including the ASTIN conference in 1981, a conference celebrating the jubilee of the ILAA in 1996, and a meeting of the International Association of Actuaries in 2000.

The ILAA organizes meetings and seminars, usually about 5 times a year, in order to promote the professional knowledge of members. Currently, there are about 120 Fellows, 60 Associates, 160 student members and 4 academic members of the Association.

In 2014, at the residence of the British Ambassador to Israel, the Association signed a Mutual Recognition Agreement with the Institute and Faculty of Actuaries, under which qualified members of the ILAA may be accepted for membership of the IFoA and vice versa, subject to an appropriate experience requirement.

## **SPONSORSHIP**
