COUNCIL AND COMMITTEE MEETINGS

Recent Meetings in Barcelona, Spain – October 17-21, 2002

The Council and committees of the IAA recently met at the Hotel Condes in Barcelona, Spain from October 17-21, 2002. Some committees have already posted their draft minutes to the site and the draft minutes of the Council meeting should be available shortly.

The meetings attracted 120 delegates (plus 46 companions) from 27 countries representing 33 associations, 3 sections and 3 institutional members. The delegates present and voting at the Council meeting, combined with the proxies and ballots received, accounted for 73.33% of the total voting rights.

In addition to the Council, the following committees also met in Barcelona: Actuarial Standards (subcommittee), Actuaries Without Frontiers (task force), Advice and Assistance, Audit, China (subcommittee), Education (also jointly with A&A and Accreditation), Executive, Financial Risks, Insurance Accounting, Insurance Regulation, Nominations, Pensions and Employee Benefits, Professionalism, Services for Individual Members, Social Security, Supranational Relations.

COMMITTEE NEWS

[IAA Guidelines of Actuarial Practice for Social Security Programs](#)

The Council approved the October 10, 2002 version of the Guidelines of Actuarial practice for Social Security Programs with an effective date of January 1, 2003. These Guidelines are available on the IAA web site under the Documents button by selecting Guidelines.

The Function of the Actuary in Prudential Supervision

This paper was approved by a ballot of Council and is available in final form on the IAA web site under the Documents button by selecting Papers.

IASB Employee Benefits Standard

The committee on IASB Employee Benefits Standard was renamed the Committee on Pensions and Employee Benefits with [new terms of reference](#). The Committee recently proposed the creation of a Subcommittee on Accounting Standards which has received the provisional approval of the President, as provided for under Article 9 of the Statutes. The [proposed terms of reference](#) will be on the agenda of the May 17, 2003 Council meeting in Sydney, Australia, for approval.

Working Party of the Committee on Insurance Regulation to Propose a Risk-Based Solvency Capital Structure

The Council approved the creation of this Working Party, its terms of reference and membership. The WP continues to work on its report "A Global Framework for Insurer Solvency Assessment", a work initiated by the IAA in support of an intent of the International Association of Insurance Supervisors (IAIS) to establish such a framework. At this point, the report is only in draft form and is incomplete. A [current draft](#) is available on the IAA website in the Members section. A final draft is expected to be available for discussion at the next committee meeting in Sydney next May.
