



CALL FOR MEMBERS TO SERVE ON THE AFIR-ERM BOARD

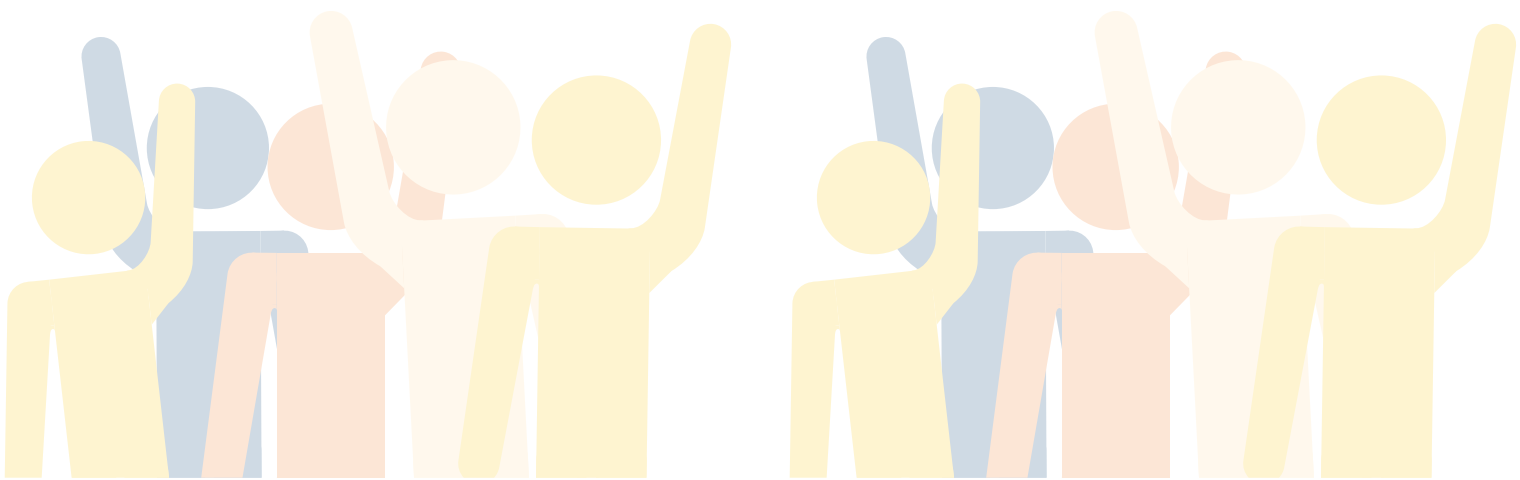
We are a group of energetic actuaries interested in financial risk, investments and ERM with the objective of developing our profession globally.
