*** Professionalism Committee review note:** The SOI was approved some years ago and work has begun on this standard, then suspended when the IAIS reopened the issue of International Capital Standards. Per ASC minutes of 29 September 2020, ASC concluded that a new SOI was not needed, and agreed to restart work on the standard.

Extract from the [ASC minutes of 29 September 2020](#):

Andrew thanked Toshihiro for preparing the background note to re-open ISAP 7. Toshihiro stated that the next key milestones of the IAIS for ICS are: 2023, Q3; Issue a consultation package on ICS as a PCR, 2024, Q3; Decision on ICS as a PCR.

It will take time for the ASC to develop ISAP 7. We should not wait until 2024, and can adjust draft ISAP 7 according to the final ICS of the IAIS when it is available, possibly in 2025.

There was a discussion whether the SOI approved for ISAP 7 is still valid. It was concluded that it is still valid given the work was only temporarily suspended, waiting for more clarity to emerge on several issues relating

to the ICS. If there is a change in scope as work is being done after re-opening ISAP7, the TF should bring this to the ASC's notice.

It was noted that the SOI for ISAP 7 was developed considering the scope of ISAP 4, so there is no necessity to revisit the SOI on account of ISAP 4.
