Motion 1: That, on the recommendation of the Executive Committee and the Nominations Committee, Council approve the changes to the Statutes, Internal Regulations and Nominations Committee Protocol as presented

Motion 2: Cancelled as a result of the COVID-19 pandemic and its impact on our future IAA Council and Committee Meetings. A new motion will be sent in a future Council ballot to propose the IAA Council and Committees Meetings take place in Brussels, Belgium in Q2-2021 and in Seoul, South Korea in Q4-2021.
